E: GENERAL TERMS, DECLARATIONS, INDEMNITY AND DATA PROTECTION

(i) GENERAL TERMS AND CONDITIONS

The investor and/or their financial advisor shall at all times be responsible for ensuring that the Unit Trust and its representatives receive any instructions from the investor and/or financial advisor, whether by email or postal mail where applicable, and that such instructions are complete and correct in all respects.
